The Center for Quality Family Support (CQFS) provides training, technical assistance, and implementation support for Maternal, Infant, & Early Childhood Home Visiting Our mission is to deliver empowering & programs. compassionate support to home visiting providers resulting in high quality family support services. The CQFS serves as the Central Administration for the 11 Healthy Families Michigan (HFM) sites as well as the 34 Parents as Teachers (PAT) affiliates. The CQFS also leads a Refugee Systems of Care Project that fosters connections between visitina system and the home refuaee services. Additionally. CQFS the employs Professional а Development Coordinator to address the training needs of all home visiting in Michigan.

Our goals are to:

- 1. Strengthen Home Visiting programs to achieve high quality implementation and improve outcomes for families
- 2. Provide access to personalized relationshipbased program support
- 3. Develop and inform the home visiting work force
- 4. Serve as the State Office for Michigan Healthy Families America and Parents as Teachers programs


# FISCAL YEAR 2023 ACCOMPLISHMENTS

Healthy Families America National Office released its 8th Edition of the Best Practice Standards in 2022. Over the course of fiscal year 2023, the Central Administration provided an array of services for the Michigan affiliates to support their understanding and operationalization of these Standards, including:



#### Overall percentage of Standards rated in adherence increased from 72% to 87%



Infrastructure support matters when it comes to impact on a home visiting system. We see that in the data related to Healthy Families Michigan affiliates' adherence to the Best Practice Standards over time. When comprehensive training, quality assurance, technical assistance and evaluation are in place. site performance improves, and families reap the benefits. Significant improvements were made between FY21 and FY23. It is worth noting increases in adherence between FY22 and FY23 because of the changes in the Standards and the learning curve that comes with any such changes.

Serving families through home visiting reauires а process of outreach. engagement and relationship building. After a family is identified, information is gathered to understand their story and determine if the services are the right fit for the family. Additionally, home visitors worked hard to connect families to resources and to provide them with information on important topics like health nutrition, counseling, care. concrete services and employment.
